

Participation Agreement, Release, and Code of Conduct

Funway Inline Hockey Program

In consideration of the services of Windmill City Entertainment, Inc., d/b/a Funway Ultimate Entertainment Center, its agents, owners, officers, employees, and all other persons or entities acting in any capacity on its behalf, I hereby agree to release and discharge Funway, on behalf of myself, my heirs, assigns, personal representative and estate as follows:

1. I agree to follow the rules as set forth by Funway, and obey the rink referee and/or supervisor at all times.
2. I understand the importance of using the protective equipment specified by Funway and agree to at least use helmets with cage, hockey gloves, protective pelvic equipment or cup, elbow, knee and shin pads and a mouth guard whenever I am on the hockey rink. The use of shoulder and chest protection would also be recommended due to the nature of the game. I understand that eye protection is also recommended. All equipment must be covered at all times. I realize that the use of the above equipment may not provide injury free protection, and take all responsibilities for my equipment and personal safety.
3. I understand that there are inherent and other risks involved in the sport of roller hockey. Injuries are a common and ordinary occurrence in this sport and I freely assume these risks.
4. I understand that while engaged in the sport of roller hockey, I will skate under control, and, if inexperienced in the use of inline skates, skate slowly. I also acknowledge that I am aware that using inline skates involves risk of serious personal injury and bodily injury from falling or striking another person or object and I will avoid all physical contact with other players.
5. I have been given the opportunity to participate in the roller hockey evaluation covering safe skating practices, hockey rules, and basic techniques. I will take full responsibility for the maintenance of my equipment. I agree to check my equipment before each game.
6. I agree to not play roller hockey under the influence of drugs and alcohol.
7. I expressly agree and promise to accept all risks existing in this activity. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to play in spite of the risks. I am solely responsible for my participation in this activity and for my physical and emotional well being. I acknowledge and understand that my participation in roller hockey is strictly voluntary, and it is my choice to participate in this activity.
8. I hereby voluntarily release, as either a player or spectator, along with any siblings who may also be spectating, forever discharge and agree to and hold harmless and indemnify Windmill City Entertainment, Inc., d/b/a Funway Ultimate Entertainment Center, its agents, owners, officers, employees, and all other persons or entities acting in any capacity on its behalf (hereinafter referred to as "Funway"), from any and all liability, claims, demands, actions or rights of action, which are related to, arising out of or in any way connected with my participation in these activities. I will have no right to make a claim or file a lawsuit against, its agents, owners, Funway, officers, employees, or any other person or entity acting in a capacity on its behalf even if they or any of them negligently caused such injury or damage.
